3. PAC Chairman Report (Chris Herron):
 - A. The status of the approval of the position of Director of Competitive Swim was not available at the time of the meeting. Lynn sent an email saying the position was approved the following Friday.
 - B. Sign up day went well. We received sign up packets for 48 new swimmers. We have not received packets from all of the returning swimmers which is preventing us from putting together the phone and contacts lists.
 - C. Due to the late timing of the practice group notifications all payments must be received no later than 9/20 instead of the first day of practice. Swimmers not paid by that day will not be permitted to practice further.
 - D. Our meetings have been rescheduled to the 1st Tuesday of the month so that Diane Case may attend.

 - B. Updating calendar – the calendar will be updated once the swim schedule has been made available.
