Facility: McHugh Natatorium in Fike Recreation Center, located at 251 Williamson Road, is an 8-lane 25-yard

pool with detached 6-lane diving well for warm down. Pool is bottom striped and wall targeted. Six-

inch non-turbulent lane lines are used. Stadium seating is available for viewers.

Rules: The meet will be conducted according to the current USA Swimming Rules and Regulations, SCLSC

Policies and Procedures, and this meet information.

Fees: \$2.50 per individual event, \$6.00 per swimmer for pool use, \$2.00 per swimmer for LSC

travel/development. Make checks payable to CAT or Clemson Aquatic Team.

Format:

- This is a Timed Finals meet.
- Athletes may enter up to 5 events per day. All 13-14 and Open events will be swum together, but scored separately.
- All 12/Under events will be scored 11-12, 10 & under
- All events 400 yards and longer are positive check-in.
- All swimmers entered in events 400 yards and longer are required to provide their own timer and counter.
- All events 400 yards and longer will be swum fastest to slowest, alternating heats of women then men.
- Late entries and positive check-in will close 30 minutes before the start of each session. Late entries after that time will be taken only at discretion of meet director and/or meet referee.
- Meet director reserves the right to adjust events/heats according to timeline; events may be combined and will be scored separately.

Scratch Rule: SCLSC rules regarding positive check-in events will be in effect.

Eligibility: This competition is open to any USA Swimming registered athlete. USA Swimming registrations will not be accepted on deck.

Entries: Please use swimmer's full name, age, and sanctioned short course yards entry times. Entry by Hy-Tek disk is encouraged. ENTRIES ON DISK USING SD3 FORMAT ARE STRONGLY ENCOURAGED. You must submit paper back-up copy and your signed team summary sheet for verification. Please send any certified or express mail with a signature release. Entries will not be accepted without payment, hardcopy, and meet reconciliation form. Email entries may be made, provided entry disk, hard copy, fees, and meet reconciliation form are postmarked by the entry deadline.

Entry Deadline: Entries must be postmarked by October 21, 2008

Email entries should include a Word document export of entries by swimmer and fee summary.

Timing: Colorado Timing System and data processing and 8-lane scoreboard. Volunteer timers from participating teams are encouraged and appreciated. All swimmers entered in events 400 yards and longer must provide their own timer and counter.

Awards: Awards will be given to places 1-8 for 10&Under and 11-12 for all 12/Under sessions; Open events are awarded as 13-14 and Open.

Time of the Meet: Friday afternoon warm-ups begin at 4:30pm, competition begins at 5:30pm. Saturday and Sunday morning sessions warm-ups begin at 7:00am; competition begins at 8:30am. Saturday and Sunday afternoon warm-ups begin not earlier than 12:00pm and competition not before 1:30pm. Meet director reserves the right to adjust times according to number of entries.

Warm-ups: Team lane assignments will be made for each session. All SCLSC and USA Swimming safety guidelines will be enforced. Lane assignments will be sent to all teams by email prior to the start of the meet and will be posted on deck and on the host website www.ClemsonAquaticTeam.org.

Officials: Certified officials willing to work are most welcome. Please report to the meet referee with your credentials when you arrive at the pool.

Coaches: Each coach must be a current member in good standing with USA Swimming and must present credentials to receive coaching packets.

Concessions: Basic concessions will be available for patrons; private meeting room is available for coaches and officials hospitality.

Directions: - From Southbound Interstate 85S: at exit 19B merge right onto US76 / SC28 up to Clemson (10mi)...OR - From Northbound Interstate 85N: at exit 14 turn left on SC187 (6 mi). At the only traffic light, turn left onto US76/SC28 to Clemson (5mi) ...

THEN, take the SC 93 exit and turn left onto SC93 for 1.4mi. You'll pass 4 lights, then * you'll see the soccer stadium and tennis courts on the left. Turn left at the next light onto Williamson Road. Fike is the first building on left. Park anytime in lot P-3 at the west end of the stadium. All other parking is restricted until 5pm on Friday. Metered parking is never free and requires payment (a few quarters or a \$96 fine).

From Ramada Inn: Turn left on US123, toward downtown Clemson. At the College Avenue light (SC133), turn left toward Clemson University. At the light at the campus (.7mi), turn hard right onto SC93. Follow from * above.

Lodging: Ramada Inn of Clemson is our host hotel and has rooms blocked for all of CAT's meets. It is located at the intersection of US 123 and US76/SC28. Phone number is 864-654-7501.
